#### ORGANOLEPTICAL CHARACTERISTICS

- Texture: smooth (fluidified by a perfectly homogeneous grinding, unctuous texture)
- Odor: characteristic of yuzu. Smell close to that of mandarin, quite fruity
- Color: golden yellow, with small highlights of orange bark
- Aroma / Taste: characteristic of yuzu. Flavor of mandarin and quite sweet, slight acidity not disturbing even for an unsuspecting consumer
